P #194749 – No samples taken. Well was not properly sealed, consisted of an open hole covered by a trash bag.

P#194749-A – No samples taken. Water well owner, Jack Wojdyla, informed that the generator is not operating properly and samples cannot be taken at this time.

P# 248878 – No samples taken. DWR permit received but well has not been completed.

P# 248879 – No samples taken. DWR permit received but well has not been completed.

P#194744 – No samples taken. Well is non-operational and cannot be sampled.
