This is an Abandoned Location Inspection for Well API# 081-07315. It does not appear that this AL Well was drilled on this Active Location; therefore this is a Well Release on an Active Location. Pit Remediation project that may have been related to this Well was closed in 2013. Well was mistakenly given PA status in 2011 Inspection because of close proximity to DA Well & Open Pit. There is some confusion in Records on Location ID# and Related Facilities assignment. When on the Ground, GPS shows three Wells at Location; AL Well 081-07315, DA Well 081-05469 & LO/SI Well 081-07427; the PR Well 081-05490 shown on this Inspection form as Related is not present & is Located approximately 3/4 of a mile to the North.
