COMMENTS:

April 1, 2015 Bailey 34-2 (123-19384) saw a 240 psi bradenhead pressure while completion operations were underway on the PDC Chesnut 27O-243 (123-39978), Bailey is approximately 127 feet west of Chesnut completion. The bradenhead pressure blew down quickly and no fluid was produced. It was then shut in and pressure built to 150 psi in 10 minutes, again, blown down then left open to tank. April 2nd flow back to tank was 20 bbl of water flowing at 18psi; April 3rd total flow back was 32 bbl. April 9th Bradenhead had been SI for several days and presently has no pressure.
