Caerus Piceance LLC ("Caerus") is in the process of applying for an Underground Injection Permit for a Class II Disposal Well with the State of Colorado Oil and Gas Conservation Commission ("COGCC").

The purpose of this letter is to provide notification to each surface owner and owner as defined in §34-60-103(7), C.R.S., within one-quarter (1/4) mile of Caerus' proposed Salt Water Disposal well ("SWD"), as is required by Rule 325.i., k and l. of the COGCC rules and regulations. Puckett Land Company and Caerus have agreed to a Water Disposal Well Agreement. The SWD surface will be located in the SENE of Section 2, Township 7 South, Range 97 West, 6th Principal Meridian, Garfield County, Colorado. The proposed injection zone of the SWD is the Ohio Creek Formation. The proposed depth of injection is 6045-6053'. The total depth of the well is 6300'.

Any person who would be directly and adversely affected or aggrieved by the authorization of the underground disposal into the proposed injection zone may file, within 15 days of this notification, a written request for a public hearing before the COGCC provided such request meets the protest requirements specified in subparagraph 325.m. of Rule 325.l. Additional information on the operation of the proposed disposal well may be obtained at the COGCC office.
