With respect to the COGCC inspection of the Bull 42-4 location (SENE Section 4 T20S R69W) on 7/12/2016, Pine Ridge submits the following information:

Pine Ridge Oil & Gas, LLC (Pine Ridge or the Company) no longer retains any access or legal rights to the surface location of the Bull yard. The Surface Use Agreement between the Company and the surface owner was conveyed to Incremental Oil & Gas, Florence, LLC in May of 2012. We have been advised that Incremental continues to use the facility as a storage yard and has maintained the lease on the property since acquiring the Florence properties.

The location was converted to a storage facility in late 2008 and an amendment was made to an existing surface use agreement between the Company and the surface owner – the Glenn E. & Betty Hopkins Trust C/O Mr. Keith B. Cramer, Sole Trustee. The facility was constructed according to the requirements of the Fremont County Department of Planning & Zoning and is compliant with the land use and zoning regulations for the County. We anticipate receiving a letter from the Department confirming the above shortly.

Pine Ridge has attempted to contact the surface owner and has recently learned that the Trusteeship has been transferred to another Trustee in California. The Company has reached out to the Successor Trustee but has not received any response yet.

The Company requests that Commission recognizes that the yard was built with surface owner approval, (subject to a private commercial arrangement), is compliant with County Zoning and that the property is now leased by a different company.
