Remediation Project Number 9666 (Document #200439556)

Attached are summary tables of laboratory results of analyses for PAHs from samples collected at the DC-11, GP-16, GP-17 and GP-19 locations earlier this summer. These summary tables are being submitted pursuant to the conditions of approval (COAs) for the remediation project referenced above.

Please note that the overwhelming majority of samples did not yield detectable concentrations of PAHs, however two (2) samples collected from the GP-16 location did contain low concentrations of several PAHs. The samples reported to contain PAHs were collected from 1) the very bottom of soil boring #3 (even though none of the samples collected from the drilling waste zone in that boring yielded detectable concentrations) and 2) the top of soil boring #7, which consists of previously stockpiled topsoil cover material that was placed over the former drilling pit. We believe that the concentrations of PAHs reported for these two (2) samples are most likely to be the result of laboratory contamination and not related to drilling waste.
