This is a request for approval of an oil-based mud drilling program for all wells on this pad. See attached Waste Management Plan for more complete information on disposal of drilling fluids and cuttings. In addition, cuttings are contained in closed loop solids control equipment; they then go through shale shakers and into a three sided bin. From there, the cuttings go into a sealed container made for cuttings. The container is picked up by truck and hauled to a landfill. All equipment is contained on the ground with a 120mm liner. Hydrocarbons will not migrate in the case of a rain event.
