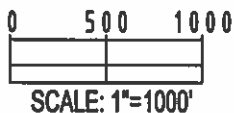
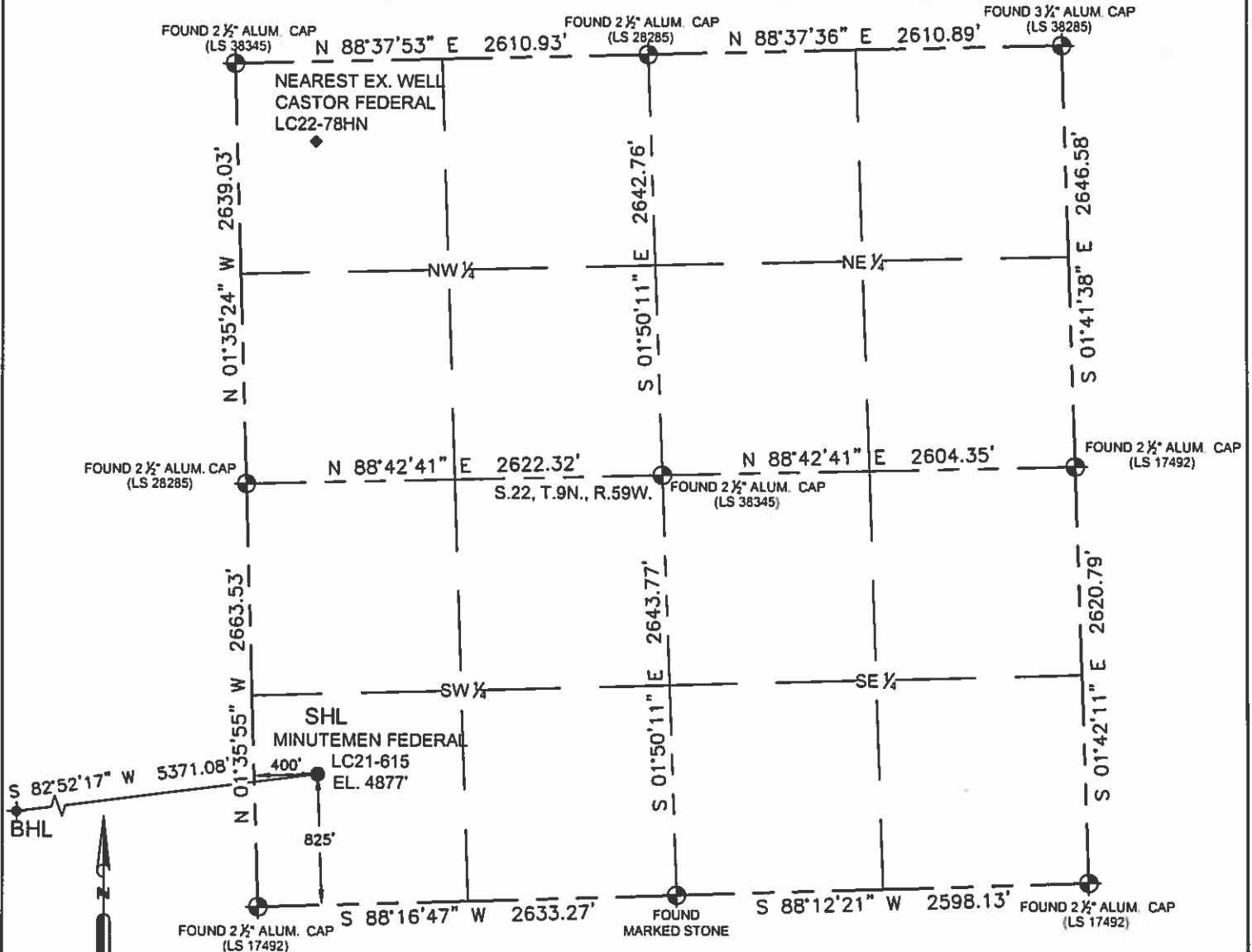


WELL LOCATION CERTIFICATE

Petroleum Field Services, LLC has determined the surface location of the **MINUTEMEN FEDERAL LC21-615** to be 825' from the SOUTH line and 400' from the WEST line as measured at right angles from the section line of **Section 22, Township 9 North, Range 59 West** of the Sixth Principal Meridian, County of WELD, State of Colorado, and the bottom hole to be 330' from the SOUTH line and 330' from the WEST line as measured at right angles from the section line of **Section 21, Township 9 North, Range 59 West** of the Sixth Principal Meridian, County of WELD, State of Colorado.

I hereby state that this Well Location Certificate was prepared by me, or under my direct supervision, that the fieldwork was completed on 04/22/14 for and on behalf of **Noble Energy Inc.**, that this is not a Land Survey Plat or an Improvement Survey Plat, and that it is not to be relied upon for the establishment of fence, building, or other future improvement lines.

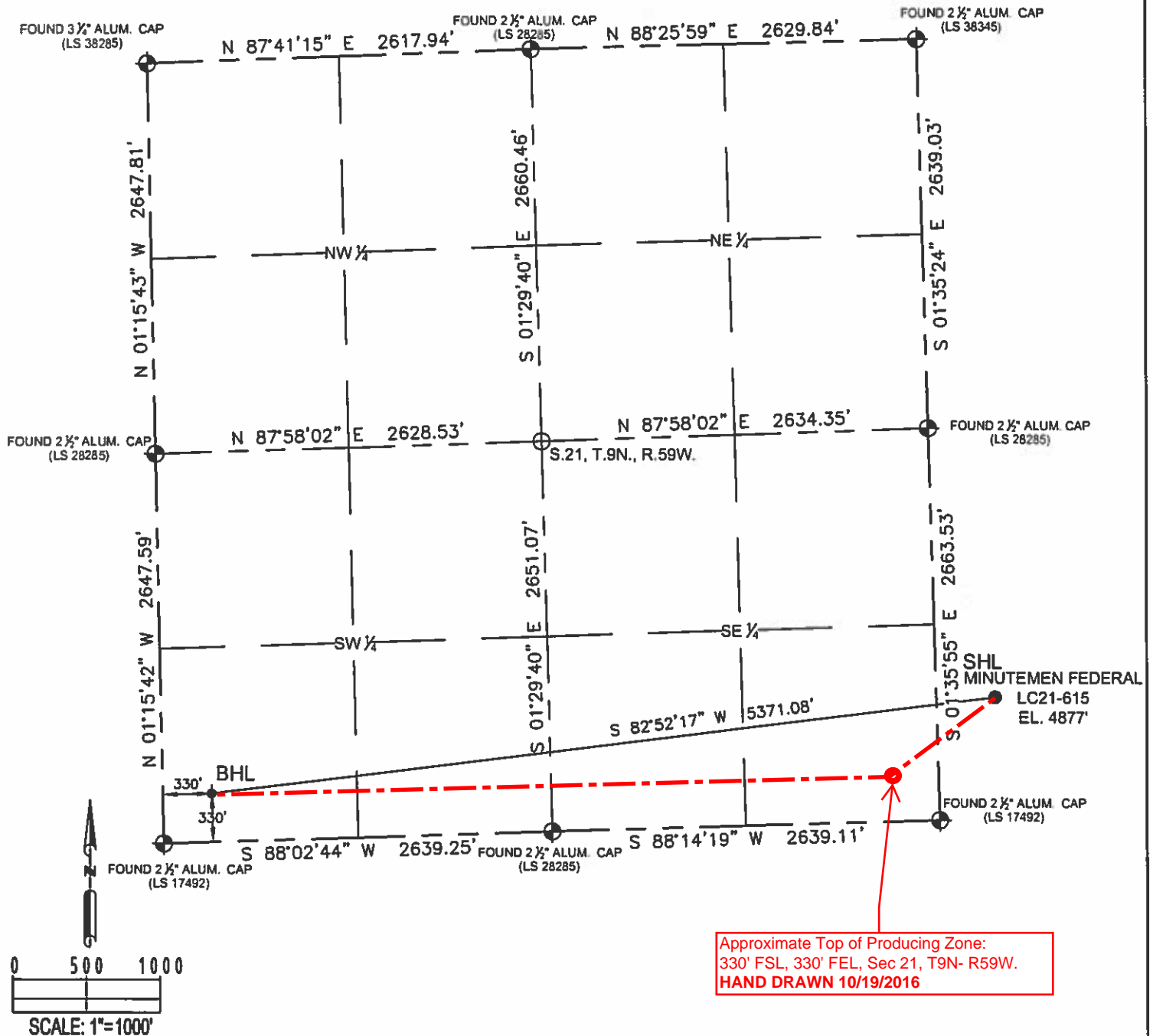
