Well location meets Rule 1004 standards; however, need to remove concrete slab and vault from tank battery location. In addition, any disturbance created during the removal of these items shall be seeded with native, perennial vegetation that is reflective of reference areas. In the absence of an agreement between the operator and the affected surface owner as to what seed mix should be used, the operator shall consult with a representative of the local NRCS district to determine the proper seed mix to use in revegetating the disturbed area. These corrective actions described above shall be completed by 03/31/2017.
