

PROCEED IN AN EASTERLY, THEN SOUTHEASTERLY DIRECTION FROM GREELEY, COLORADO ALONG U.S. HIGHWAY 34 APPROXIMATELY 25.4 MILES TO THE JUNCTION OF THIS ROAD AND COUNTY ROAD 87 TO THE NORTH; TURN LEFT AND PROCEED IN A NORTHERLY, THEN EASTERLY DIRECTION APPROXIMATELY 3.0 MILES TO THE JUNCTION OF THIS ROAD AND COUNTY ROAD 89 TO THE NORTH; TURN LEFT AND PROCEED IN A NORTHERLY DIRECTION APPROXIMATELY 3.9 MILES TO THE JUNCTION OF THIS ROAD AND AN EXISTING ROAD FOR THE HAWKINS 5-61-21 WELL PAD TO THE EAST; TURN RIGHT AND PROCEED IN AN EASTERLY, THEN NORTHERLY DIRECTION APPROXIMATELY 457' TO THE EXISTING HAWKINS 5-61-21 WELL PAD AND THE PROPOSED ACCESS TO THE NORTHWEST; FOLLOW ROAD FLAGS IN A NORTHWESTERLY, THEN NORTHERLY DIRECTION APPROXIMATELY 625' TO THE PROPOSED LOCATION.

TOTAL DISTANCE FROM GREELEY, COLORADO TO THE PROPOSED WELL LOCATION IS APPROXIMATELY 32.5 MILES.

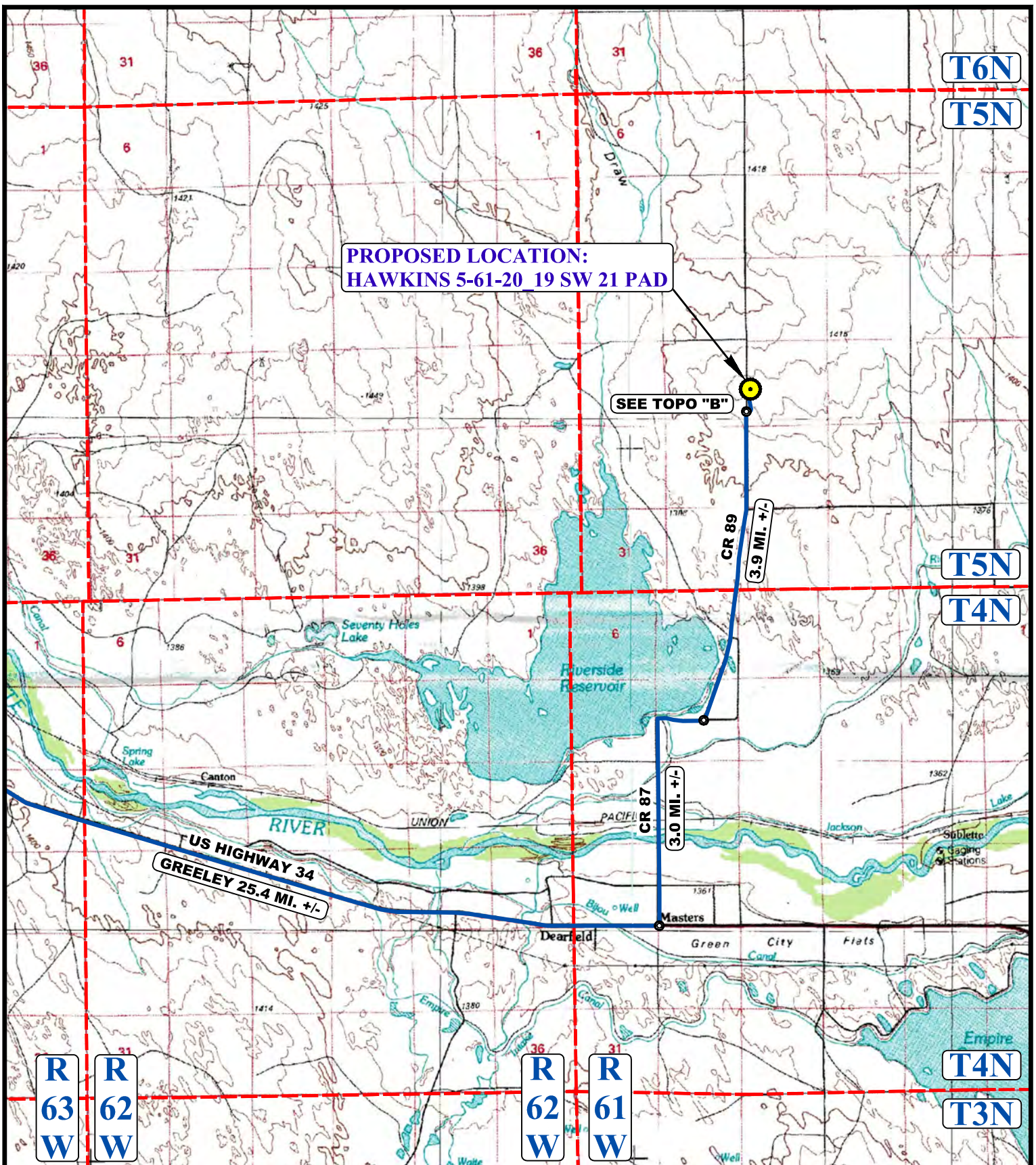
