The operator and the complainant were able to reach a mutually acceptable solution to the produced water pit maintenance activity. The operator agreed to scrape soil from the ground outside the base of the berm to add to the top of the berm rather than removing soil from inside the pit. The operator will install a method to monitor a minimum of 2 feet of freeboard in the produced water pit.
