The subject well was drilled and completed in November 2001. Production from the well was limited from January 2002 to May 2002. Following P&A operations in June 2002, all equipment was removed and the site re-contoured. The site is located on cropland (see attached aerial photos from 2005, 2011, 2013 and 2015). The landowner or tenant farmer has resumed farming this area. A Kerr McGee pipeline pigging station is located approx. 750 feet northwest of the former wellhead.
