Response to FIELD INSPECTION FORM Document #682501307 Corrective Actions Required. As per corrective action required, QEP Energy Company will cut the casing off 4 feet below surface and will cap with a below surface dry hole marker (welded plate) that will contain the well's legal information. QEP will notify the COGCC 48 prior to work commencing.

QEP will then recontour and reclaim location in accordance with COGCC 1000 Series Reclamation Regulations, specifically Rule 1004 Final Reclamation of Well Sites and Associated Production Facilities.

QEP will onsite the location on November 15, 2016 and will have all work completed by the COGCC stated deadline of March 30, 2017. QEP will recontour the location and establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of pre-disturbance or reference area levels. QEP will use a seed mix that matches the adjacent pastureland or a seed mixture requested by the landowner. QEP will ensure erosion controls are implemented to stabilize the seeded soil and will continue to monitor the site until Final Reclamation has passed.

QEP will notify the COGCC when the site is ready for a final inspection as per Rule 1004.c.
