COMMENTS:

Noble Energy intends to drill the subject well as a monobore. The surface casing will be set deeper to cover the base of the Pierre Aquifer for Oil based mud considerations. Intermediate casing will not be run. Oil based mud will be planned for the production interval only. Noble Energy shall isolate both the Fox Hills and Upper Pierre Aquifers with surface casing from hydrocarbon bearing zones and exposure to oil based drilling fluid. Noble Energy also agrees to not expose the Upper Pierre Aquifer to oil based mud. All cuttings will be taken to a certified disposal.
