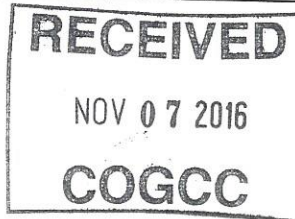

Dear Ms. Arthur:

In December of 2015, the surface owner, Shane Miller wrote a letter indicating that he did **not** wish the concrete pad located on his property to be removed. A copy of the letter from Mr. Miller is attached for your records. As a result of this request from the surface owner, when the Estate of Rex Monahan was coordinating the reclamation/remediation work on this site, the cement pad was not removed.

We believe all other remediation work regarding this Well has been completed. The most recent Field Inspection Form, dated October 18, 2016, Document Number 682501412 indicates that the removal of the cement pad is still a requirement. I enclose a copy of the latest Field Inspection Form for your ease of reference.

As I mentioned, we believe the reclamation/remediation efforts have been completed. In light of the consent from the surface owner, would you please revise Document 682501412, which would result in this Well meeting all reclamation requirements. 
Please be advised that Miller Chance Investment Corporation is the surface owner of the NE/4NW/4 of Section 25, Township 7 North, Range 53 West of the 6th P.M., Logan County, Colorado. This is the location of the former well described as AEU 7, being your facility ID/API Number 05-075-05281, and lying within the Atwood East Field.

I recently met with staff from Rex Monahan Estate's office to discuss the unsatisfactory status of this former well site, and specifically the concrete pad located on this property. The purpose of this letter is to inform you that I do not desire this concrete pad be removed from this land, as I utilize the pad on occasion for equipment storage and the like. My understanding is that if the surface owner requests the concrete pad to remain, you will amend your records so that the Monahan Estate will not be required to remove it.

If you need something else from me, or my corporation to authorize the non-removal of this concrete pad, please let me know. I enclose with this letter an 8.5" x 11" color photograph of the pad in this location.
