This is an Abandoned Location Inspection, Bond Release Related for Well API#045-10864; OXY is Operator of Record for this Well; Laramie Energy is Operator of Location which has AL Status . Well was never Drilled. Two Pits listed in Related appear to be the One Pit that was Active on Location. This pit was closed under F-4 doc #400499065 10/24/13. Although it complied with COAs, the F-4 was never approved. Environmental Specialist is closing both (1) pits in the d-base. F4 - Variance Request 9/4/12 for change of use for Location – was Denied (deleted 8/22/14). This is also a follow-Up to Inspection Doc#663902102, 8/30/2013 which called for Final Reclamation to begin by 9/28/2013. Since Change of Operator has occurred & New Operator has accepted Responsibility, Corecctive Action Date has been Extended.
