Properly select, install and maintain site specific stormwater and sediment control BMPs to prevent further incision and degradation to the intermittent stream. Remediate soils (if needed) within areas of produced water spill until soil meets COGCC 910-1 standards. Establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of pre-disturbance or reference area levels. Use a seed mixture requested by the landowner. Ensure erosion controls are implemented to stabilize the seeded soil, and continue to monitor and manage this site until Final Reclamation has passed. Remediation and revegetation activities shall be complete no later than 11/15/2016

Well file documents and past NOAVs state produced water had been discharged into drainage/downstream. Approximately 200 yards of intermittent stream, downstream of location remain unvegetated, records indicate this is a result of salt kill due to produced water.
