COGCC has reviewed the Site Investigation and Remediation Workplan submitted by LT Environmental on behalf of Synergy Resources Corporation for the Toedtli 22-2 produced water pit complex. Based on the information provided, no further action is required to investigation impacts related to hydrocarbon impacts to soil at the pit complex. However, additional investigation needs to be conducted to determine the horizontal and vertical extent of impacts related to the inorganic parameters EC, pH and SAR. As you are aware, the COGCC will generally apply the Table 910-1 concentration levels for pH, SAR, and EC to soils that are within three (3) feet of the ground surface because elevated levels of pH, SAR, and EC in deeper soils should not adversely affect the successful reclamation of the site, which is the objective of these concentration levels. The initial sampling program conducted as part of this investigation indicates that the EC exceeds the Table 910-1 level in the upper three feet of the soil at the location.

Remediation Project #9950 has been assigned to this project and will remain open pending further investigation at the site. Likewise, pit facility ID #258442 will remain open.

Please note that all reports relating to Form 27s should be submitting using the eForm 27 beginning January 1, 2017.
