#### COMMENTS:

No MIT test is required as the well is an "open hole" completion and drilled entirely in the Mancos Shale. Spudded in the "Buck Tongue" member, surface casing set through the Castle Gate Member at 250 ft and drilled to TD in the Mancos Shale. The 7 inch casing was run due to fractures, some oil and lost circulation. The 5 1/2 inch production string run to a final depth of 3,098 ft. with bottom joints slotted. No cement.

**Operator Comments:**

In 2015, Northwest Pipeline informed Premium Oil Co. (now Apex Oil Ventures as of 12/2015), that they would not accept any more gas through the "White River Meter" and to their pipeline connection until an automated gas processing plant installed. The cost as supplied by NW Pipeline was about \$1 million. With low gas prices this was non-economical. The #7 well is SI due to no market for the gas and also to retain reservoir formation pressures to maximize the oil production in the nearby #14 well. A casing pressure guage on the #7 well has been monitored over the years at between 90# to 110#.
