ASSIGNMENT

THIS ASSIGNMENT made and entered into this first day of October, 1973, by and between INDUSTRIAL GAS SERVICES, INC., a Colorado corporation, and THOMAS G. VESSELS, an individual, hereinafter referred to as "IGS" or "Assignor" and "Vessels" or "Assignee", respectively;

## WITNESSETH THAT:

Assignor, whose address is 4704 Harlan Street, Denver, Colorado 80212, for and in consideration of ten dollars (\$10.00) and other good and valuable considerations paid by Assignee, whose address is 180 Cook Street, Denver, Colorado, the receipt of which is hereby acknowledged, does hereby assign, transfer and convey unto Assignee all of Assignor's right, title and interest in and to the Gas Purchase Agreement, dated May 1, 1968, marked for identification purposes as Contract No. 68651, Exhibit "A", attached hereto, incorporated herein, and by this reference made a part hereof.

AND for the same consideration, the Assignor covenants with the Assignee, its successors and assigns, that Assignor is the lawful owner and has good title to the said Gas Purchase Agreement described in Exhibit "A". That all conditions necessary to keep same in full force and effect have been duly performed and that Assignor will warrant and forever defend the same as to all claims by, through or under Assignor, but not otherwise.

Assignee by its acceptance hereof agrees to be bound and to comply with all terms and provisions of said Gas Purchase Agreement as fully described in Exhibit "A" hereof.

This Assignment is effective as of 7:00 A.M. on October 1, 1973,  
regardless of the date of execution of this instrument.
