Comment: The vegetation has not established at the location or along the access road and the soils seem to be compacted. The access road has not been recontoured. See Attached Photos

Corrective Action: Recontour the access road. Decompact soils by cross ripping to a minimum depth of 18 inches. Reseed the location and access road to facilitate vegetation establishment. Stabilize the disturbed soils until vegetation establishes (e.g. weed free mulch).
