## COMMENTS:

As provided for in the Materials Management Plan for Drill Cuttings submitted to the COGCC on May 1, 2015 (Document Number 400834133 and 400834135), TEP Rocky Mountain LLC (TEP) wishes to manage drill cuttings from additional locations at the Sandridge 399-1-3 Cuttings Management Location (COGCC facility ID 316509). Additional approved drilling locations have been added to TEP's drilling schedule, and there is insufficient area to manage all cuttings from the planned number of wells on each pad; therefore, it is proposed that any excess cuttings from these locations that cannot be managed on location, be taken to, and managed at TEP's Sandridge 399-1-3 Cuttings Management location. This Cuttings Management location is located on private surface owned by TEP, and as previously documented, is located in an environmentally acceptable area for this use. All provisions regarding the physical management of the cuttings, and record keeping as prescribed by the Materials Management Plan will continue to be applicable and adhered to.

Specifically, TEP requests that the following locations be added to Table 1 (Waste Generation Locations) on Page 9 of the Materials Management Plan.
