 ASSIGNMENT OF LEASES, RIGHT-OF-WAY GRANTS, PERMITS AND LICENSES

KNOW ALL MEN BY THESE PRESENTS:

That the undersigned W. H. Gilmore and Harry P. McClintock as managing partners of CANON & GILMORE, a partnership composed of M. O. Borling, Jr., Craig O. Canon, Robert E. Canon, W. H. Gilmore, W. H. Gilmore, Jr., Reed Gilmore and Harry P. McClintock, in consideration of Ten Dollars (\$10.00) and other valuable considerations receipt of which is acknowledged, does hereby assign, (DELAWARE) transfer and convey unto SUN OIL COMPANY, those certain leases, right-of-way grants, permits and licenses described in Exhibits C and E attached hereto and made a part hereof, and all other leases, easements, right-of-way grants, permits and licenses under and pursuant to which CANON & GILMORE constructed, installed, operated and maintained its pipelines, pipeline facilities and installations, roads and telephone and electric lines used in or in connection with the construction and operation of its gasoline plants and in the movement of gas and the products extracted from gas to and from said gasoline plants owned by CANON & GILMORE and situated in Section Thirty-One (31), Township Four (4) South, Range Sixty-Three (63) West, Arapahoe County, Colorado and Section Seventeen (17), Township Six (6) South, Range Sixty-Two (62) West, Elbert County, Colorado, together with all the rights, privileges, easements and estates granted or conferred thereby in the lands covered by the same, all covering in Elbert and Arapahoe Counties, Colorado.

TO HAVE AND TO HOLD the same unto SUN OIL COMPANY, (DELAWARE) its successors and assigns, and SUN OIL COMPANY, (DELAWARE) accepts the same and agrees to perform all of the covenants of the holder thereof accruing after the effective date and time of this Assignment.

CANON & GILMORE represents and warrants that said leases, right-of-way grants, permits and licenses are valid and now in full force and effect, that it has not committed or allowed to be committed any act not in accordance with the (DELAWARE) terms thereof, and that SUN OIL COMPANY will hereby be vested with the right to use the rights, privileges and estates granted or created by said leases, right-of-way

grants, permits and licenses in the manner in which CANON & GILMORE has used the same and in any other manner permitted thereby. CANON & GILMORE does further bind and obligate itself, its assigns, its members and their heirs and assigns, to warrant and forever defend said leases, right-of-way grants, permits and licenses, the land covered thereby and all of the rights, privileges and estates thereby granted or created unto SUN OIL COMPANY, ^(DELAWARE) its successors and assigns, against the claims of all persons whomsoever lawfully claiming or to claim the same or any part thereof or interest therein.

This Agreement shall be effective as of 7:00 o'clock a.m. the 1st day of March, 1973, and shall be binding upon the parties hereto, their heirs, successors and assigns.
