Add six (6) water tanks, eleven (11) separators, four (4) electric motors, two (2) LACT Units, one (1) gas compressor, sixteen (16) oil tanks, two (2) VRU's, and two (2) produced water skids to the location. Therefore, the new totals are twenty-two (22) water tanks, nineteen (19) separators, four (4) electric motors, two (2) LACT Units, one (1) gas compressor, thirty-two (32) oil tanks, two (2) VRU's, and two (2) produced water skids.

The modification of this existing oil & gas location was within the originally disturbed area, and there was no additional surface disturbance. In addition, the modification did not change the cultural distances included on the original Form 2A.
