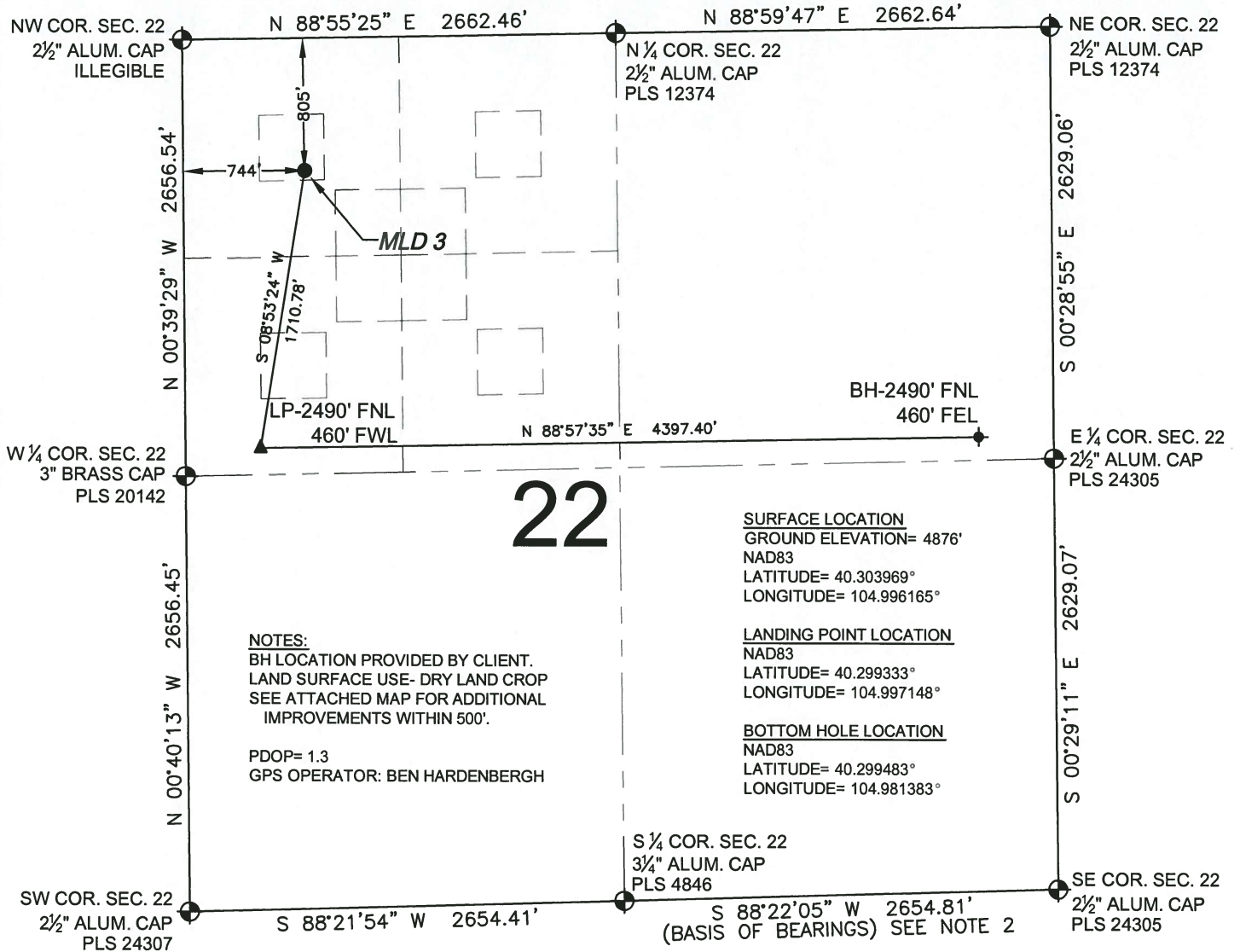


# WELL LOCATION CERTIFICATE: MLD 3

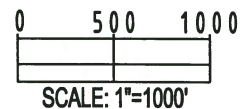
- ⊕ = EXISTING MONUMENT
