I'm fine with the changes. I'll make a note in the well file.

The plug from 1320-870' must be tagged at 870' or shallower. After pumping this plug shut down and WOC at minimum 4 hours. Confirm there is no longer gas or liquid migration to the surface. If there is any indication of gas and/or liquid migration through this plug contact COGCC for an update to plugging orders.

Sampling of fluids from the bradenhead was required as a COA on the Form 6 Intent. The Form 17 from 12/06/2016 indicates no samples were collected. Samples must be collected prior to plugging.

Diane,

As discussed on the phone, we'd like to change the P&A for the Waterfront 7-34X (API# 05-123-24474) with the following:

- Dismiss the cement and mud plug from 2252'-2452' (cmt) and 2452'-3100' (mud)
- Do not tag the SUSX balance plug because there is no susx/sh production within 1 mile

- Cut casing at 1220'. Pump cement from 1320' to 870' with 170 sx of gasblok cement. Tag this plug.
