The bottom hole location is being extended so it now falls 50' FEL of Sec 25. Great Western will not perforate within 150' of the east line. Attached is a wellbore schematic with more detail. This exception to the typical 460' setback was granted approval through docket number 17010056; order 407-1880. Attached is an updated plat, directional data, and deviated drilling plan. The production casing design has also been updated due to the change in the bottom hole. Surface has been set and will be reported on the form 5.
