#### COMMENTS:

Gas pipeline is 18 miles away, and it would cost in excess of \$1 million to install. At this time there are no other wells producing that would make this investment economic. The well makes less than 5 MCFD, some of which is consumed by the engine on the pumping unit. The well also has a 95% efficiency closed-combustor installed on location to destroy any additional produced gas, and a combustor on the oil tanks to destroy any tank emissions. The CDPHE permit is in process (attached).
