Comment: The cattle guard and gates remain at the beginning of the access road. The access road has not been reclaimed and gravel remains along the road. The location has been partially recontoured. There are areas near the center of the location that have compacted soils. The soils have not been adequately tilled to establish a proper seedbed. It does not appear the disturbed soils have been seeded. The disturbed soils are susceptible to erosion. See Attached Photos

Corrective Action:	Remove cattle guard, gates, and reclaim the access road as required. Recontour and decompact soils by cross ripping to a minimum depth of 18 inches. Adequately till the soils to reestablish a proper seedbed. Seed all disturbed soils and stabilize the soils with a certified weed free mulch or equivalent method.	Date	05/01/2017
