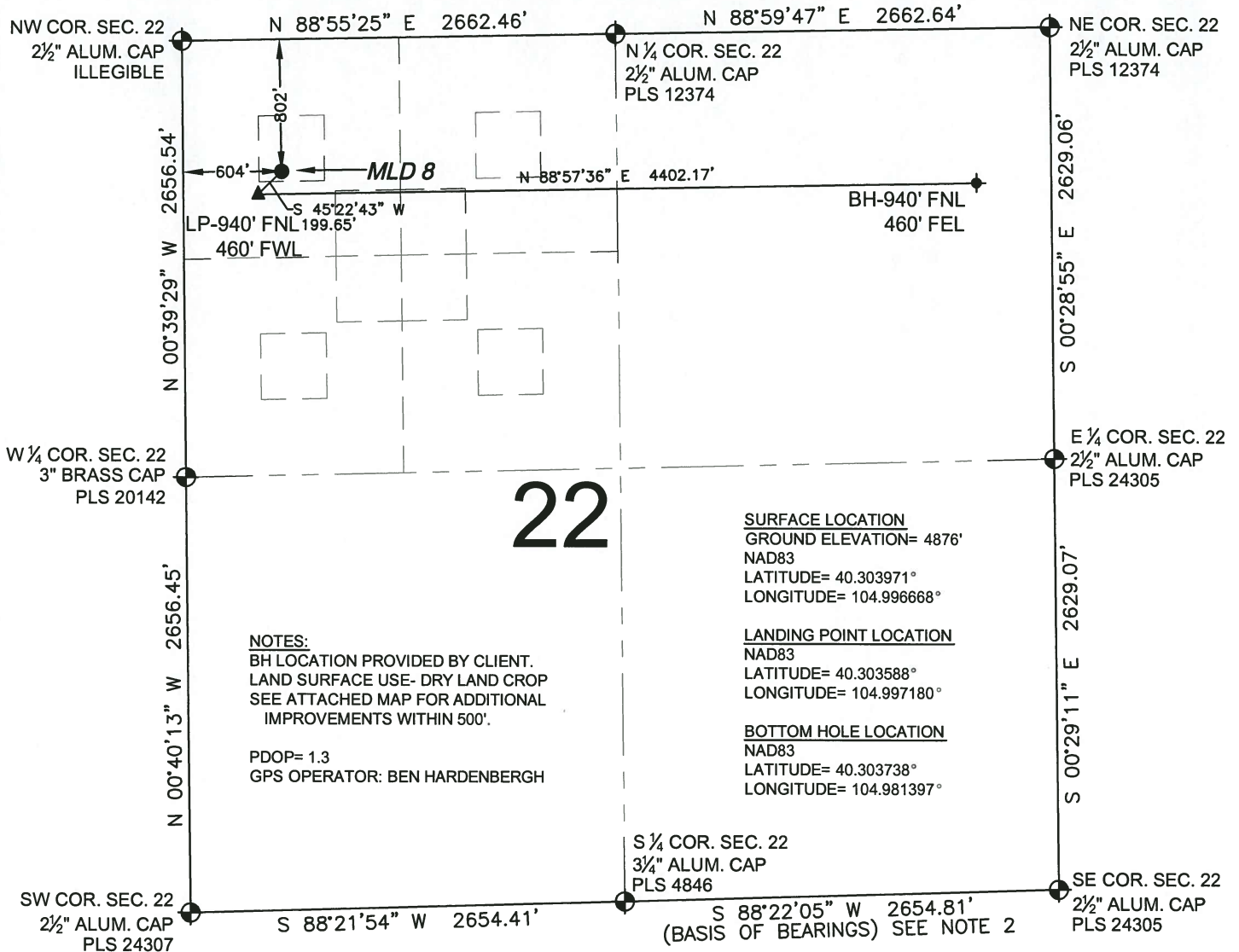


WELL LOCATION CERTIFICATE: MLD 8

LEGEND

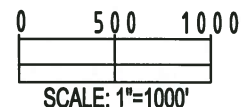
- = EXISTING MONUMENT
