Colorado Oil & Gas Conservation Commission (COGCC) Rule 318A.c. states that any new well is to be located within 50 feet of an existing well. Extraction's above referenced wells are being permitted as exception locations since they are located greater than 50' from the nearest existing well. Currently these wells are located 491 feet from the nearest well. These wells are being proposed at this location due to an agreed upon location in the Surface Damage Agreement with the surface owner. Extraction has obtained written permission from the surface owner by way of signed waiver.

Extraction respectfully requests the COGCC to review the enclosed information and approve the requested exception location and Application for Permit to Drill for the wells on the subject pad. Many thanks.
