Pioneer is reporting completion of final reclamation for the Fisher 22-36 API # 05-071-09687; and Fisher 22-36 Tr API # 05-071-09746; well locations located in Las Animas, County Colorado. During the consultation process the surface owner requested that the well location and r-o-w be returned to the condition they were prior to Oil and Gas activity. The well location has been fully reclaimed and the Right-of-Way has been returned back to a two track road which existed prior to construction of the well location. The surface owner has a specified seed mixture which was utilized on the r-o-w. The seed Mix is known as the Twin Peaks seed mix.
