Comment It does not appear that Location Footprint has been reduced since Construction & Well Completion. Large areas of Compacted/Graveled Pad area are attempting to revegetate with desired species as well as Weeds. Plumeless Thistle (B List Noxious) and Various Annual Weeds that will break off/blow and become Debris were noted on site. Thistle is also evident at Entry area off Access Road. Refer to Photos attached for more Detail.

Corrective Action Shrink Location for Interim Reclamation as per COGCC 1003 Series Rules. Conduct Reclamation in areas no longer needed for Use or Production. Reclamation Activities should be completed by June 1, 2017. Control Weeds, Noxious & Annual (that will become Debris) on Site, beginning Control program in Spring 2017.
