Field Inspector Actions:

On 3-6-2017, I was contacted by James Precup NE supervisor of the COGCC in reference to a noise/odor complaint at the residence of the complainant Bart Stoneback 848 WCR 17 Brighton, CO 80603.

Upon contacting the complainant, he indicated the noise was very loud coming from the frac operation located to the SW of his home he also indicated he was getting strong emissions coming from the vehicles at the location when the winds were blowing toward his home.

I performed a complete site inspection of the location on 3-6-2017. At the time of inspection, I observed sound walls on the east side of location as well as trailers with bales used for sound mitigation on the north end of location. Due to high winds in the area at the time of the inspection, I was unable to perform a sound study. The high winds in the area also made it difficult to detect any odors of location. Wind speed were approx. 20 to 40 mph at the time of the inspection.

I contact PDC staff and requested any possible sound study information they may have had from the location.

All information reviewed and site inspection information were submitted to the complaint specialist for further review. No violations of COGCC rules were observed at the time of the inspection.
