Bill Barrett Corporation is submitting this sundry per conversation with Melissa Housey on 3/16/17 to advise COGCC that the surface owner has requested the topsoil removed from this location be temporarily relocated to an area off pad to allow more room for agricultural operations. The topsoil will be retained for final reclamation needs as there be more topsoil removed than is necessary for interim reclaim operations. The preserved topsoil will be stabilized with seed and mulch.
