Use a seed mixture requested by the surface owner or a seed mixture provided by the county Natural Resources Conservation Service. Ensure erosion controls are implemented to stabilize the seeded soil, and continue to monitor and manage this site until Final Reclamation has passed. Revegetation activities shall be complete no later than 5/31/2017
