Encana respectfully requests continued TA status for the subject well.  
The well was TA'd due to sub-economic production. A CIBP was set at 3243' and topped with 2 sxs of cement, which covers the Williams Fork perfs at 3304'-5532'. There is no tubing in the well and the master valve on the wellhead is closed to insure the well is closed to the atmosphere.  
Encana plans to review the economics and any future development prior to running the next MIT.
