Magna Well Services. RIH notched collar on 2-3/8" tubing. Tagged shoe plug at 1023'. Pump 40 sx at 615' displace with 1.5 bbl. Pull up to 32'. Pump 12 sx @ 32' to surface. Observed contaminated soils around WH and in ditch adjacent to east of well. Prior to excavating, estimated 1/2 bbl: crude oil and water. 1 cu yd contaminated soils 20'x3'x6". Collected liquids in vac truck. Excavated +/- 4 cu yds contaminated soils, put on plastic. Dug out WH. Cut casings: 13-3/8" and 9-5/8" at 5 ft bgs. Welded on plate w/ well ID. Backfilled with clean soils from earthen bank to north, adjacent to well, using rubber tire backhoe. Removed anchors.
