Comment: Location ID 320259 with API 001-08787 does not meet Rule 1004 standards as the disturbance of the location is evident and mainly consist of weedy, annual vegetation. The disturbance location is not reflective of reference area vegetation that is comprised of Crested wheatgrass (Agropyron cristatum).

Date **05/31/2017**

Establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of pre-disturbance or reference area levels. Use a seed mixture requested by the surface owner or a seed mixture provided by the county Natural Resources Conservation Service. Ensure erosion controls are implemented to stabilize the seeded soil, and continue to monitor and manage this site until Final Reclamation has passed. Revegetation activities shall be complete no later than 5/31/2017
