Comment: Green completions equipment on location operated by LEC. Flowback of two wells occurring during inspection. Hydraulic stimulation of another well being performed by Haliburton. No propanant being used during stimulation. Flowback equipment consists of an inclined unit to separate junk from plug drill out, a vertical separator for each well being flowed back, and a horizontal unit for additional separation. Fluids are then piped to tanks and gas is routed to an enclosed flare until salable. Two enclosed flares on location for flowback and two additional combustors for production equipment. Temporary frac tanks on location to store produced water are connected to a pipeline system.
