This is a Final Reclamation Inspection prompted by Bond Release Request for PA Well API#077-08579, a Fed Mineral / Fee Surface Location. This is also a Follow up to Insp Doc#668401714 dated 9/26/2013. Well was Spud 4/14/1986 by Resource Enterprises Inc; Plugged and Abandoned 10/26/2012 by Oxy USA. Previous Inspection called for Location to be Reclaimed and Noxious Weeds controlled. Location had a Variance request that had been pushed back to Draft at time of Company transfer to Laramie Energy. Current Operator requested COGCC withdraw Form 4 Variance request, as defunct/closed accounts of Oxy made Form inaccessible to Operator. It was decided that review & evaluation of Site by Operator & Inspection by COGCC would determine if New Variance Request should be Submitted. Three issues need to be addressed before Location itself can be PASSED. 1) Wattles become Debris when no longer needed for stabilization of site; Location cannot be Released for Final Reclamation when these Temporary SW controls are still in Place. 2) B list Noxious Weeds, Houndstongue & Thistle on location as well as Curly Dock (not listed, but a troublesome perennial). 3) Location is not gated off and a Tracked disturbed area is evident where heavier Weed growth is noted</p> <p>1) Remove Wattles if determined no longer needed for stabilization of site; addressing any disturbance created by removal. 2) Control Noxious Weeds on Location. 3) Assess area disturbed by Vehicle traffic & determine what, if any actions are needed (i.e. interseeding/exclusion of Traffic) for progression of desired vegetation. 4) Reclaim Access Rd or apply for Variance request.</p>	Date 06/15/2017
