Dear Mr. Carlson:

Western Environment and Ecology, Inc. (Western Environment) is pleased to provide the following documentation of the excavation, transport and disposal of petroleum contaminated soil from the above referenced property (Figure 1). The contamination was first described in a Limited Phase II Environmental Site Assessment prepared by CTL Thompson Inc. (CTL) dated January 9th, 2017. The report identified petroleum contaminated soil and groundwater at the location of a produced water storage tank (Figure 2). Following a January 16th, 2017 meeting between yourself and Scott Carlson of Carlson and Associates, Terry Hodge and Tony Dunning of Toll Brothers, Matthew Wardlow of CTL and Western Environment, it was determined that additional investigation was needed to evaluate the extent and magnitude of soil and groundwater contamination encountered in the January 9th CTL assessment.

The ensuing Western Environment report, "Limited Phase II Environmental Site Assessment for the Holly Hills Subdivision at 144th Avenue and Holly Street, Thornton, Colorado" dated February 7th, 2017, described the results of three additional groundwater monitoring wells and eleven soil borings which bracketed the CTL Thompson wells. Laboratory results of groundwater samples were below the Colorado Oil and Gas Conservation Commission (COGCC) and US EPA Drinking Water Maximum Concentrations Levels (MCL's) for benzene, toluene, ethyl-benzene, and xylene (BTEX). However, analysis of the soil samples reported that several exceeded the COGCC regulatory limits. Western Environment concluded that "that approximately 550 cubic yards of petroleum hydrocarbon contaminated soil above COGCC levels should be excavated, transported and disposed of at an approved facility".

This recommendation was presented to the COGCC in Form 19, Spill/Release Report on February 23, 2017 by Jack McCartney of McCartney Engineering, LLC. In addition to the excavation and disposal of contaminated soil, Western Environment recommended quarterly groundwater sampling for a year to confirm BTEX levels remain below US EPA, MCL's. Chris Canfield, Environmental Protection Specialist for the COGCC, reviewed the recommendation and approved the remediation work under Form 27 (COGCC Project Number 10065) assigning a Project Number of 10065.

Using the data collected in the February 7th report, waste characterization for disposal as Non-Hazardous Special Waste (attached) was received from the Front Range Landfill on March 15th, 2017. Beginning on March 20th, 2017, a track excavator removed the upper 4 to 5 feet of "clean" soil before encountering contamination. The clean material, which was identified visually and by photo-ionization detection (PID), was stockpiled to replace the excavated soil. Contaminated soil extended from approximately 5 feet to a maximum depth of 18.0 feet below the surface. Four hundred and eleven (411) tons (approximately 330 yards) of contaminated soil was excavated and loaded directly on trucks for transport to Front Range Landfill in Erie, Colorado (see attached photos). Waste disposal manifests are attached to this report. No groundwater was encountered in the excavation.

After removing the contaminated material, Western Environment acquired four conformational soil

samples from the base of the excavation (at approximately 16.0 to 18.0 feet) and six soil samples from the walls of the excavation pit (at approximately 12.0 to 13.0 feet). These samples B-01, B-02, B-03, B-04, W-01, W-02, W-03, W-04, and W-05 were transported under Chain of Custody to Technology Laboratories in Fort Collins, and analyzed for BTEX and TVPH utilizing US EPA Method 8260 and 8015.

The results of the samples (attached) were received on April 5th, 2017, and are presented below.

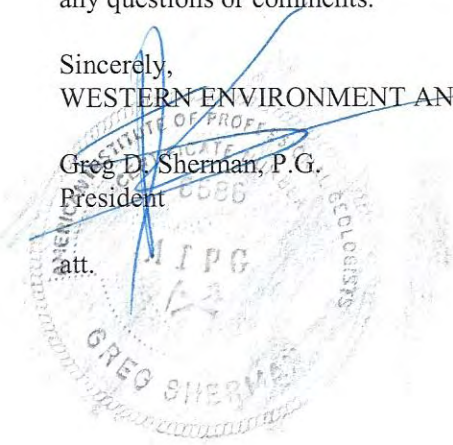

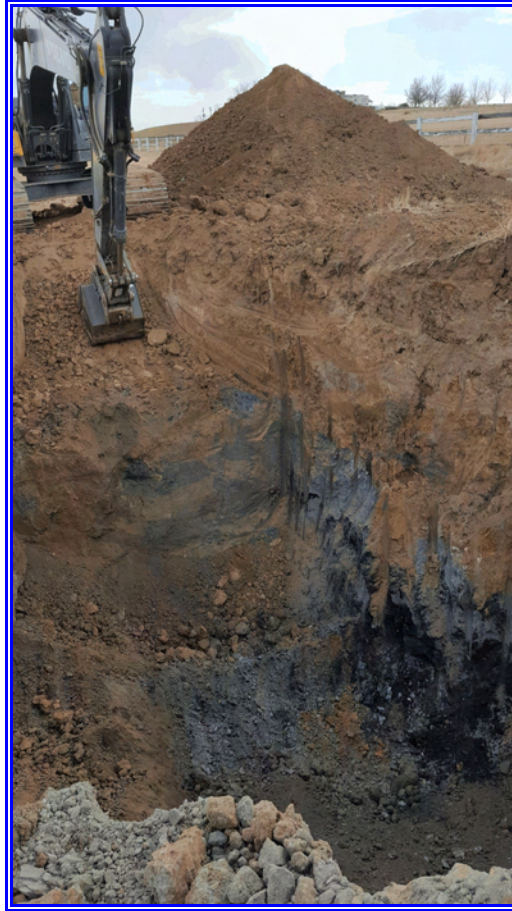




View of the excavation from the northeast



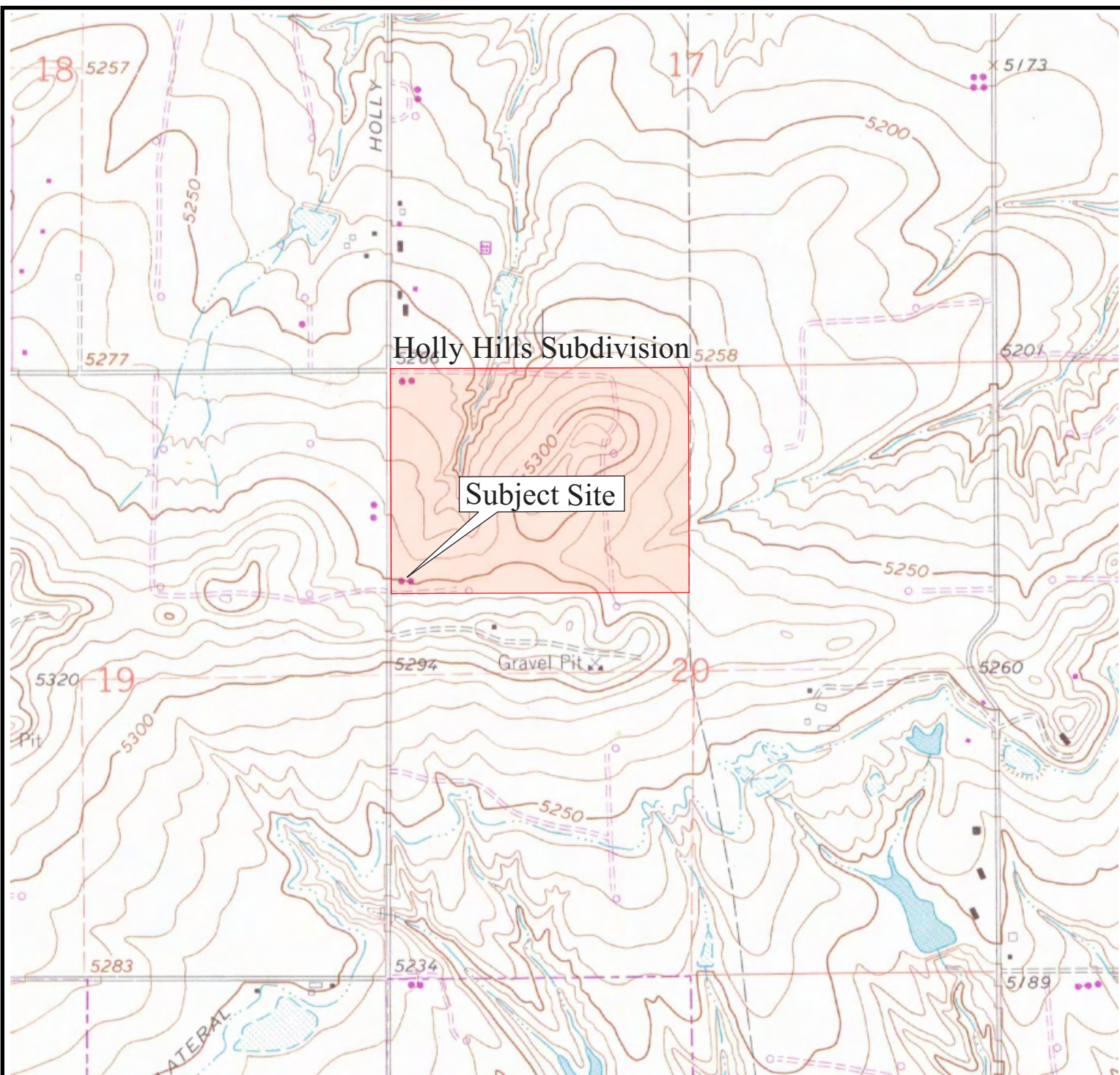
View of the excavation from the southeast

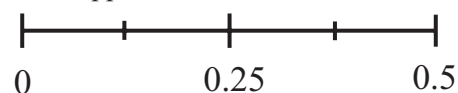
View of the soil excavation area following fill of clean material on March 22nd, 2017



USGS Eastlake Qaudrangle, 7.5 Minutes Series, 1980

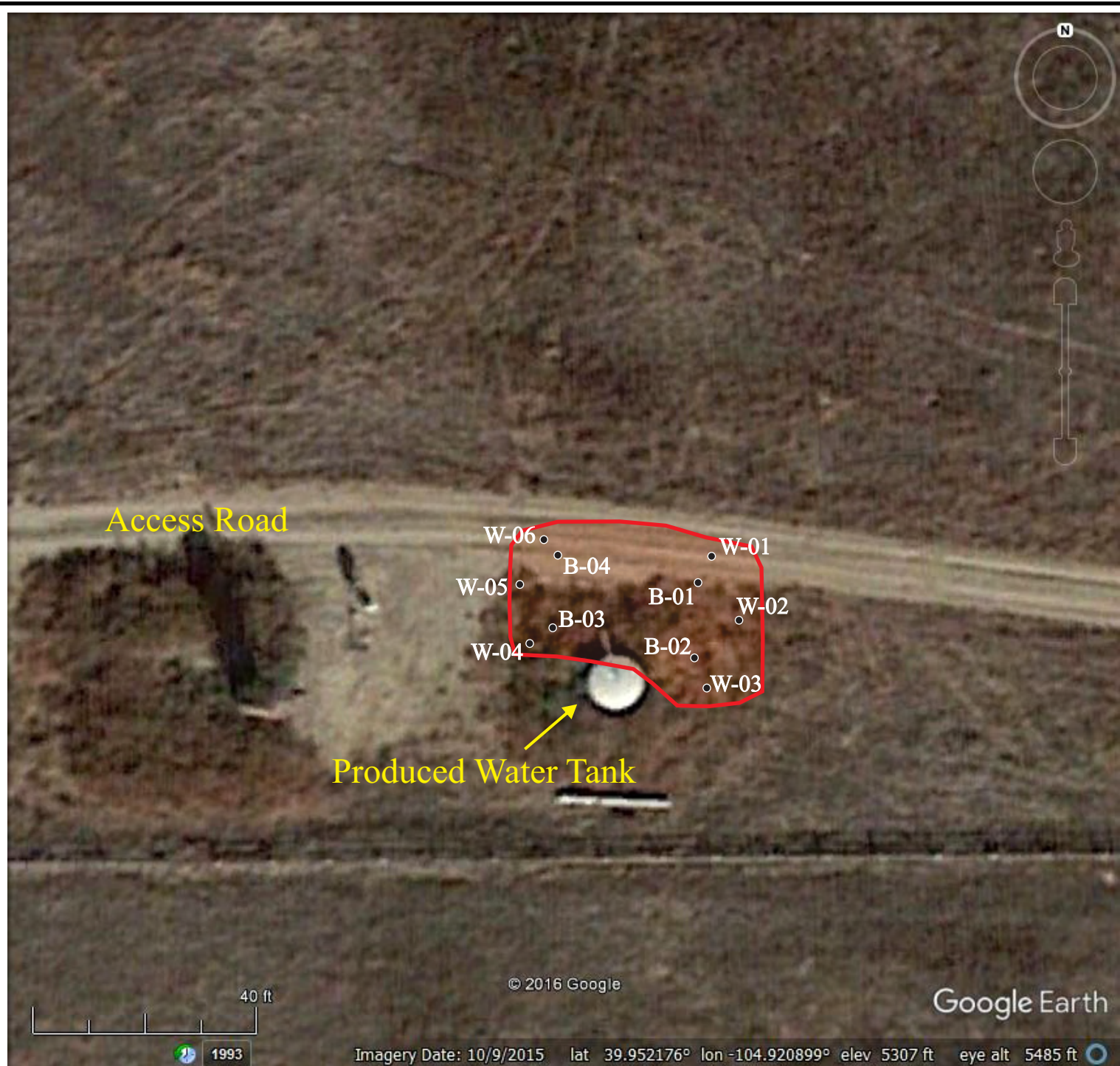

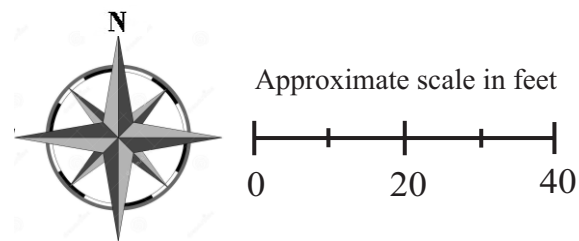
