Wexpro Company cannot find any documentation that this facility was ever constructed after permitting in 1986. I've attached Google Earth imagery from 1993 and 2016 showing no signs that any such facility was ever built. Also attached is a COGCC database search of the NWNW section 33, 12N, 97W that doesn't show any Central Disposal Facility. Please see the GIS (1990's aerial) attachment from COGCC showing the Carl Allen 12 pit (facility 116531-closed) in the same location of the GPS coordinates listed for facility 116578. I believe that facility 116578 was permitted, but never constructed. Wexpro Company requests closure and NFA for facility 116578.
