Operator Comments:

In response to Inspection No. 675200946, Encana Oil and Gas (USA) Inc. has reviewed the area noted as having sediment migration on location, and has determined that a puddle was formed after a rain/snow event in the area, and that no sediment had migrated from off location. Encana is currently using natural BMPs on location, such as vegetative seeding/growth along the cut-slope, which serves as a natural berm to reduce the effects of such events & prevent sediment migration. Encana will continue to monitor the location and make necessary improvements to the existing surface BMP's currently in use on the location.

As requested in the inspection, Encana is submitting site-specific BMP's that are appropriate for this location given its geographical considerations, and to accommodate heavy precipitation this location may receive, especially during the winter months.
