The access road remains to the location and was seeded and straw mulched. The straw mulch is no longer present in many areas and vegetation is beginning to establish. There is no gravel that remains at the location or along the access road. The location has not been recontoured and the pit remains. There are noxious weeds (Plumeless thistle, Mullein) beginning to grow in areas around the pit. Early season weed control will need to be performed. See Attached Photos
