Operator Comment: Scotch thistle stalks were removed during recontouring/regrading work. New plants germinating between start of  
work and reseeded were addressed by spot spraying herbicide. The site will be evaluated for noxious weeds  
within a few weeks of revegetation, and addressed as warranted.

Corrective Action: Remove equipment, re-contour location and establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of pre-disturbance or reference area levels. Use a seed mixture that matches the adjacent pastureland, a seed mixture prescribed by the county's NRCS office or a seed mixture requested by the landowner. Ensure erosion controls are implemented to stabilize the seeded soil, and continue to monitor and manage this site until Final Reclamation has passed. Revegetation activities shall be complete no later than 4/30/2017

Operator Comment: The site recontoured/regrading in March. Stormwater erosion/channeling was repaired, and the site was contoured to minimize runoff. Inclement weather delayed seeding until mid-April. The seed mix used applied was based on landowner preference, based on in-person discussions. The seed mix is comprised of buffalo grass, blue grama, and sideoats. Crimped straw mulch was applied to seeded areas to prevent erosion and promote revegetation.
