OPERATOR COMMENTS AND SUBMITTAL

Comments This is an unplanned sidetrack that occurred while drilling the CVR 5-63-32-4956B2 API# 05-123-44256. BBC required to open hole sidetrack our 6 1/8" lateral hole due to a 28' fish left in the hole from 9553' – 9581' MD (the fish is a 4 3/4" motor and 6 1/8" bit). 9 5/8" surface casing is set at 821' MD, 7" intermediate casing is set at 6744' MD (LP) and the total depth of the wellbore to be abandoned is 9581' MD. Description of proposed plugs: No cement plug, open hole side track will be utilized. Measured depth of proposed sidetrack kick-off point 8666' MD. Proposed objective formation (Niobrara) for sidetrack hole and BHL target remains the same as originally planned (930' FSL, 500' FEL, Section 33 T5N R63W).

Approval to proceed with the sidetrack was provided on Thursday, 4/27/17 by Diana Burn, following a phone call on Wednesday, 4/26/17 with BBC engineer.
