SG is proposing to change the drilling plan for the approved Federal 11-90-15 #3 well (API 05-051-06129). This well was originally proposed to be a horizontal mancos well. SG is proposing to drill a horizontal coal well and a sidetrack from that well (lateral 1). Attached are revised directional plans for the Federal 11-90-15 #3 wellbore and sidetrack (lateral 1), wellplot and drilling plan. The drilling plan also includes proposed casing and cementing program as outlined in the approved APD Drilling COA #1. The well surface location has not changed. SG is in the process of revising the bottom hole plats and will submit them to the BLM upon receipt.

On April 26, 2017, SG submitted and had had verbal conversations with Peter Cowan, Acting Branch Chief of Fluid Minerals regarding a 3rd revised Application to amend the depth and number of horizontal laterals in the first Test Well in the unit: "SG would like to drill two Cameo Coal Formation horizontal lateral wells utilizing the same location as the previously proposed Mancos
