- 2) Control well with kill fluid
- 3) Tag fill with 1.66" production tubing. POOH.
- 4) RIH w/ Bit & Scraper. Clean out to PBTD (tally in). TOOH
- 5) RIH w/RBP. Set RBP @ +/-6520', spot 2 sx of sand on top of RBP. Test RBP 1500psi. TOOH
- 6) Bleed off bradenhead, unland casing, and nipple up dual outlet wellhead. (no history of bradenhead pressure issues. Contact engineer and rig superintendent if pressure exists above 50psi)
- 7) Run down annulus with 1 1/4" tubing to 1448', condition hole.
- 8) RU cement crew, pump 595 sxs 15.8ppg "G" neat cement bringing cement to surface (25% excess volume assumed)
- 9) POOH with 1 1/4" tubing, land casing.
- 10) SI well overnight, run CBL recording new cement depths
- 11) RIH with retrieving head to 6496' and circulate hole 2x hole volume (200bbls or 8000gal) to clean sand off top of RBP
- 12) Continue RIH to 6520' to latch onto RBP and bring to surface
- 13) RDMO Workover rig, pump & tank
