Access road Leading into Location from County Rd has not been reclaimed. From aerial imagery it appears this road was originally constructed as access road for two wells in area, though now it is being utilized by current Landowner as Property access. Operator should be aware that Variance for this road being left unreclaimed may be needed before Final Reclamation Release of this Location. On Pad site, seeding installed in 2016 is just emerging through Straw Mulch. On Aerials it appears trees that encircle location may have been planted in early 2000s.
